SONATRACH Privacy Policy

SONATRACH places the utmost importance on protecting your privacy and respecting your personal data. This privacy policy aims to inform you about how your personal data is collected, used, and protected in connection with your registration and participation in the 12th Scientific and Technical Days (JST12).

1. Collected Personal Data

We collect the following types of data:

- Full name
- Date and place of birth
- Nationality
- Postal address
- Phone number
- Email address
- Job title
- Photos and videos
- Identification document number, place, date of issuance, and expiration date
- Passport number, place, and date of issuance

This data is necessary to process your requests, manage your registration, and ensure the quality of our services.

2. Purposes of Data Processing

The personal data collected is used to:

- Provide and improve the services offered on the website.
- Manage your registration and participation to the JST12.
- Facilitate communication between participants and organizers.
- Ensure the security and legal compliance of the website.

3. Legal Basis for Processing

The processing of your data is based on the following legal grounds:

- **Consent:** By submitting a form or registering, you explicitly consent to the processing of your data.
- Legitimate Interest: To manage interactions related to our professional activities.

4. Data Recipients

The data collected is strictly reserved for:

- Our internal teams, as part of their professional duties.
- Our technical service providers (solely for maintenance or website hosting purposes, and under contracts ensuring data confidentiality).

Your data will not be shared with third parties without your prior consent, except in cases of legal obligation.

5. Data Retention Period

Your personal data will be retained only for the duration necessary for processing, specifically:

- Ten (10) months from the date of your registration.
- A longer period if required by legal or contractual obligations.

After this period, the data will be deleted or anonymized.

6. Data Security

We implement technical and organizational security measures to protect your data against unauthorized access, loss, alteration, or disclosure. These measures include:

- The use of secure protocols (HTTPS).
- Restricted access to data for authorized personnel only.
- Regular audits to ensure the security of our systems.

7. Your Rights

In accordance with applicable regulations (Law 18-07), you have the following rights:

- 1. Right of Access: You can request to view the personal data we hold about you.
- 2. **Right to Rectification:** You can request the correction of inaccurate or incomplete data.
- 3. **Right to Erasure:** You can request the deletion of your data, subject to our legal obligations.
- 4. **Right to Object:** You can refuse the use of your data for specific purposes.
